
### **Emissions reduction targets**

### Carbon reduction projects

#### **Completed carbon reduction initiatives**

The following environmental management measures and projects have been planned for 2024:

- We've measured Associated Optical's 2023 carbon emissions by partnering with Trace, an Australian-born, female founded climate-technology company on a mission to reduce the barriers for businesses to understand their impact on the environment. By providing our operating data across categories such as energy usage, business travel, purchased goods and services, and waste we can now see a breakdown of how our key emissions sources across different areas of our operations.
- We plan to procure certified 100% renewable electricity for all of the sites that we are in control of the supply
- We are in the process of changing all our fluorescent lighting to LED alternatives. We plan to replace light switched with sensors in key areas to ensure unnecessary energy usage.
- Planned 30% reduction in printers across our office portfolio to reduce both paper and energy usage.
- We plan to expand on our hybrid company fleet to create an EV adoption strategy to electrify our entire fleet when battery technologies advance
- We plan engagement lunches and sessions to build awareness amongst our workforce to discuss the impact of their decisions on our journey to Net Zero
- We plan to create a plan to reduce commuting emissions.
